BC to advise in due course.</p> <p>BC provided a report on the current SPA situation as follows: -</p> <p><b><u>SCOTTISH PAIRS 2004</u></b></p> <p>We as a league have had thirteen pairs entered for the 2004 Scottish pairs qualifying event, which I am still awaiting conformation on how many qualifiers we will gain. (I have verbally been told the qualifying event will be held in our own area).</p> <p>The cost will be £3.00 per player to play in the qualifiers with a format of best of 3 frames until required qualifiers have been reached. As each player will be asked to pay a small entry fee, their will be excess funds available for our league funds (Approx £200-£300 per season if all events are entered). This extra revenue could be put to a number of uses i.e</p> <ol style="list-style-type: none"> <li>(1) Prize money for our league competitions</li> <li>(2) Help finance a weekend singles competition</li> <li>(3) Finance qualifiers accommodation (League are already prepared to do this)</li> <li>(4) Have polo shirts showing league crest, these being given to players who qualify for main event.</li> </ol> <p><u>S.P.A.
