- 1) All matches shall be played in accordance with North Berwick and District Pool League Rules.
- 2) All entrants are obligated to give their name and a contact number with their entry fee (£10).
 - 2a) Any person failing to provide name, fee or contact number shall not be entered into competition.
- 3) All matches shall follow the format of - Best of 5 frames, except in:-
 - 3a) Round Robin all 3 frames to be played.
 - 3b) Semi finals shall be best of 7 frames.
 - 3c) Final shall be best of 9 frames.
- 4) All matches shall be completed by the date shown on fixtures which will be displayed from 02-04-05.
 - 4a) Failing to complete match by final date shall be void (except for Rule 4c).
 - 4b) Any player having difficulties contacting their opponent should contact Brad Chisholm on 07989 199 003 or Dave Kerr on 07791 916 330 before the final date shown on fixture list.
 - 4c) If a player is unobtainable after all means of contact, and their opponent has contacted Brad Chisholm or Dave Kerr before the final date shown on fixture list, the unobtainable player shall lose the match.
- 5) Matches shall be played at an agreed venue within North Berwick between the players concerned - Except 5a.
 - 5a) Semi finals and final shall take place in the Quarterdeck Bar (date still to be arranged).
- 6) All match results shall be phoned/given to either Brad Chisholm, Dave Kerr or the Quarterdeck Bar.
 - 6a) Failing to provide a result will declare the match void.
