	<p>S.P.A. MATTERS (NORTH BERWICK LEAGUE)</p> <p><u>Super League</u></p> <p>I have been approached by the Scottish Pool Association regarding 12 man super league team.</p> <p>This event will be held at Pettycure Bay, Fife end of February 2006. Cost £360 per team (this breaks down to £30 per person). This cost covers 2 x caravans £130 each plus E100 entry fee. Final entry date 4th December 2005 with fees being paid at January meeting.</p> <p><u>National Events</u></p> <p>Due to recent disputes at national events qualifiers all singles, doubles, IM Tour draws will now be made at a central venue and all leagues will be drawn separately.</p> <p><u>Black Ball Rules</u></p> <p>Black Ball Rules come into effect 1st January 2006 and will be introduced into SPA events early March 2006. All leagues have been asked to send 2 members to a meeting which is to be arranged to define all new rules.</p> <p><u>January AGM</u></p> <p>Held 8th January 2006 at Ex-Serviceman's Club, Rosyth.
